The undersigned further hereby agree(s) to hold harmless and indemnify Faith Evangelical Presbyterian Church, its directors, employees and agents from any liability sustained by said church as the result of negligent, willful, or intentional acts of said participant, including expenses attendant thereto. The undersigned also understands that any raw video footage or photographs taken during said trip or activity may be used for future publicity.

2018 Faith Kid's Summer Camp Expectations

- From the time campers arrive until they are picked up by their parents, they are under the supervision and authority of the Summer Program Staff. Campers are expected to obey all requests made by the staff in a prompt manner.
- There is 100% participation in all activities by all campers, unless there are health concerns.
- No whining or complaining! Any camper deemed to be whining will be warned and then be made to sit out of the next activity. If behavior continues, parents will be notified during pick up.
- Campers must stay within the site area. There will be no going outdoors unless the program staff grants permission.
- Under no circumstances will there be any hitting, kicking, fighting, verbal abuse or any other sort of abuse during camp week. Failure to follow this rule will be grounds for immediate dismissal from camp.
- Campers may not leave to go home without making sure one of the program staff is aware.
- NO electronics! We will be very active at camp leave all game systems, music players, cell phones, etc. at home. Program staff will provide a phone should a student need the use of one.
- Follow the Fruit of the Spirit: Love, Joy, Peace, Patience, Kindness, Goodness, Gentleness, Faithfulness and Self-Control.
